Owatrol International warrants Shed And Fence Paint against peeling on horizontal surfaces such as wooden decks for a period of 5 years, and 15 years on vertical surfaces such as cladding, from the date of purchase when applied to a properly prepared uncoated or stripped surface in accordance with the label instructions and Technical Data Sheet. Owatrol International will at its discretion replace the material or refund the purchase price if Shed And Fence Paint does not perform as described above. OWATROL SHED AND FENCE PAINT LIMITED WARRANTY - FULL TERMS AND EXCLUSIONS

Owatrol International warrants Shed And Fence Paint against peeling on wooden decks for a period of 5 years and on cladding a period of 15 years, subject to the following Terms and Exclusions. This warranty is nontransferable.

TERMS

- a) All surfaces must be prepared according to the label instructions and Technical Data Sheet.
- b) Due to printing limitations and ongoing product development the Technical Data Sheet will always supersede any label instructions and it is the responsibility of the purchaser to ensure they have the most up to date Technical Data Sheet prior to commencing work.
- c) All previously coated surfaces must be stripped back to bare wood excluding the following products, which must have been allowed to weather unmaintained for a minimum period of 12 months prior to applying Shed And Fence Paint. Owatrol Textrol, Owatrol Aquadecks.
- d) The term "Deck" includes handrails, spindles, posts and any other such wooden item used in the construction of the deck.
- e) Owatrol International will only be liable for the cost of replacement material or the original purchase price of the material.
- f) All claims must be made in writing and accompanied by proof of purchase.
- g) All new wood must have been allowed to weather for a minimum period of 6 months prior to the application of Shed And Fence Paint subject to any restrictions indicated in the Technical Data Sheet.



- h) In the event of a claim being made where Shed And Fence Paint has been applied to a new deck then Proof of Purchase must be accompanied by a dated copy of the final invoice for the deck construction.
- i) Owatrol International reserves the right to modify or improve formulations without prior notification.

EXCLUSIONS

- a) Does not cover the cost of time and labour in part or whole where a claim may be made and validated.
- b) Does not cover workmanship in the event of the product being applied by a 3rd party e.g. contractor.
- c) Does not apply to problems caused by the alteration of this product, improper storage, misuse or accident.
- d) Does not apply to problems caused in whole or in part by abrasion, mechanical damage e.g. scratches, abuse or damage resulting from chemicals or exposure to harmful solids, liquids or gases and which may lead to the finish peeling.
- e) Does not cover damage or defects to the coating, caused in whole or in part by fire, explosion, flood, acts of God, vandalism, negligence or any other similar causes beyond the control of Owatrol International and which may lead to the finish peeling.
- f) Does not cover normal wear and tear.
- g) Does not cover damage to the coating, which may subsequently lead to peeling of the finish where repairs have been carried out to the deck after completion of the work.
